2026 CORPORATE PASS ANNUAL MEMBERSHIP AGREEMENT

Springbank Links Offers:

- 1) Forty (40) Corporate vouchers (green fee, cart & warm-up bucket at range)
- 2) Valid Monday through Friday, after 3:00 pm Saturday, Sunday & holidays
- 3) Name three additional Corporate Players for booking and charging privileges
- 4) Upgrade option for the Corporate "Plus" (\$500 to play anytime)
- 5) 8-day advance booking
- 6) Member charge account (for each player)
- 7) Member-Guest rates for your guests
- 8) Member-Guest rates when outside your playing window (before 3:00 pm on Sat., Sun & holidays).
- 9) Private locker(s)
- 10) Towel service
- 11) Men's Night / Ladies' Night, with guests
- 12) Club storage option (\$150 per)
- 13) Range option for Unlimited Range (\$299 per player for unlimited buckets)
- 14) Pickleball Membership option (Individual, Couple, Family)
- 15) Golf Canada Membership option (\$55 pe player)
- 16) No restrictions on the number of rounds played per week.
- 17) Passes may be used as a single, twosome, threesome, or foursome

Terms & Conditions:

- 1) Springbank Links Golf Club is a privately owned and operated golf club. All operations and policies are exclusively managed by Springbank Links Golf Course Ltd. (the "Club").
- 2) The Company or group has assigned the below Corporate Player (the "Main Player") as evidenced by his or her signature below and shall be authorized to sign this Agreement on behalf of the Company or group.
- 3) The Main Player may name up to three additional players (collectively the "Players") to also be annual corporate members, with the same privileges at the Club.
- 4) The Players hereby agree to be governed by and subject to all rules and regulations adopted and amended from time to time by the Club concerning the use, operation, and administration of the Club and its facilities. The Club shall set the dress code, speed of play, hours of play, booking privileges, and general rules.
- 5) **The Company agrees to pay \$4,250 plus GST to activate the membership and privileges.**
- 6) The Company may upgrade to the Corporate "Plus" for the passes to be valid anytime (not restricted before 3:00 pm on Saturday, Sunday, and holidays) for an additional \$500.
- 7) The Players shall receive private lockers (one per player) with combo locks for the season.
- 8) The Players have the option to purchase the following upgrades:
 - **Club storage** - \$150 per player, subject to availability
 - **Golf Canada Membership** - \$55 per player that includes: the Golf Canada handicap system and insurance for carts, clubs, and windows.
 - **Unlimited Range** - \$299 per player. The passes include a warm-up bucket associated with a round of golf. Unlimited Range means unlimited buckets anytime at the driving range for practice throughout the season.
 - **Pickleball Membership** – Unlimited play & privileges - \$100 Individual, \$150 Couple, \$300 Family.

- 9) The Players may participate in Men's or Ladies' Night, with guests. Any event fees, such as a prize pool and/or a Deuce Pot, would be an additional charge.
- 10) The Company shall have a minimum clubhouse expenditure of \$300 per player collectively over the season. This expenditure shall include items from the clubhouse food & beverage. Should the collective amount not be reached by the end of the season, the difference shall be charged to the Player's or Main Player's credit card(s) on file with the Club.
- 11) This Agreement is non-transferable and shall expire the day after the final day of the 2026 golf season.
- 12) The Players are welcome to play in the restricted periods (before 3:00 pm weekends and/or holidays) at the Club's Member-Guest green fee rate and shall retain the 8-day booking privilege.
- 13) **The Main Player and Players agree to fill out the MEMBER INFORMATION & CHARGE ACCOUNT AGREEMENT (attached) to activate booking privileges and charge account(s). The Club is hereby authorized to settle any charges to the card on file unless otherwise settled. The Club reserves the right to suspend or terminate privileges on overdue accounts.**
- 14) Any tee times not canceled within the Club's cancellation policy (24 hours) shall be considered used, and one corporate voucher shall be forfeited per unused tee time, or the equal dollar amount of green fee(s) shall be charged to the delinquent Player's account.
- 15) Vouchers may not be used for tournament play. A maximum of 8 vouchers may be used per day.
- 16) **Any unused vouchers at the end of this season shall expire and will not carry over to the next season(s).**
- 17) The Players understand and accept that the Club will host tournament play within the corporate playing window.
- 18) Management of the Club shall have the right to suspend or expel the Player should a breach of these terms and conditions or if the Player's conduct is determined by Management to be improper, unbecoming, or likely to endanger the interests or reputation of the Club. No Player shall be suspended or expelled without first being given prior written notice of the charge of complaint against him/her and without having first been allowed to be heard by the Management at a meeting called for that purpose. Any Player who is expelled from the Club or whose privileges are terminated, withdrawn, or delinquent shall forthwith be deemed to have relinquished all rights, claims, and interest in and to the privileges and any remaining vouchers.
- 19) The Player(s) shall have conclusively deemed to have agreed that neither Springbank Links Golf Course Ltd., the owners, directors, general manager, employees, nor agents thereof shall be responsible in any way whatsoever for any loss of property or damage to person or property of any Player or guests in or about the facilities, the golf course lands, or elsewhere, or arising directly or indirectly from the use or occupation of the golf course lands or adjacent lands.
